Introduction - PMI

Executive Summary

Established in 1969 and headquartered outside Philadelphia, Pennsylvania USA, the Project Management Institute (PMI®) is the world's leading not-for-profit project management professional association, with over 100,000 members worldwide.

History

The Project Management Institute was founded in 1969 by five volunteers. The Commonwealth of Pennsylvania USA issued Articles of Incorporation for PMI which signified the official inception of the organization. During that same year, the first PMI Seminars & Symposium was held in Atlanta, Georgia USA and had an attendance of 83 people.

In the 1970s the first issue of Project Management Quarterly (PMQ) was published and later renamed Project Management Journal® (PMJ). The first Annual Seminars & Symposium was held outside of the USA, the first PMI Chapter was chartered and the PMI Professional Awards Program was established. By the end of the decade PMI membership totaled over 2,000 individuals worldwide.

HISTORY (cont.)

During the 1980s, PMI's membership, programs and services continued to grow. A Code of Ethics was adopted for the profession and the first Project Management Professional (PMP®) Certification examination was administered. The first PMI project management standard was published as the PMQ Special Report on Ethics Standards and Accreditation. PMI's publishing products and services also grew rapidly during this decade. The first PMI book was co-published and PM Network®, PMI's monthly magazine was born. Due to this growth, the PMI Publishing Division was established in North Carolina USA.

By 1990, PMI's membership totaled over 8,500 and by 1993 the annual membership growth rate rose to over 20 percent per year. During the 1990s, Specific Interest Groups and Colleges were formed and Seminars USA, a series of educational programs on project management was initiated (later renamed SeminarsWorld™). PMI also established a presence on the World Wide Web and published the project management standard, A Guide to the Project Management Body of Knowledge (PMBOK® Guide). PMI Today®, PMI's monthly newsletter was printed for the first time and the Professional Development Program (PDP) was established for PMP certificate holders to maintain their credential.

By the beginning of the 21st century, PMI had over 50,000 members, over 10,000 certified Project Management Professionals and over 270,000 copies of the PMBOK® Guide in circulation.

PMI's premiere standards document, A Guide to the Project Management Body of Knowledge (PMBOK® Guide), is a globally recognized standard for managing projects in today's marketplace. The PMBOK® Guide is approved as an American National Standard (ANS) by the American National Standards Institute (ANSI). PMI is committed to the continuous improvement and expansion of the PMBOK® Guide, as well as the development of additional standards.

Certification

Since 1984 PMI has been dedicated to developing and maintaining a rigorous, examination-based, professional certification program to advance the project management profession and to recognize the achievements of individuals in project management. PMI's Project Management Professional (PMP®) certification is the world's most recognized professional credential for individuals associated with project management. In 1999, PMI became the first organization in the world to have its Certification Program attain International Organization for Standardization (ISO) 9001 recognition.

Research

OVERVIEW OF PMI/NJ NETWORKING PROGRAM

Mission: Develop, execute and revitalize on a continuing basis a PMI NJ Networking Program uniquely aimed at the needs of Project Managers and hiring industries. The Program leverages its experienced membership base as a forum to exchange information on qualified opportunities, business contacts and candidates. As a model for standards, the Program is executable at any PMI affiliate while offering the flexibility to individual chapters to tailor it to their specific needs.

Objectives:

- Phase I involves a monthly interactive meeting format, held in conjunction with PMI/NJ's General Meeting.
 - **Immediate goals include:**
 - • inspire and build drive of under- and unemployed PMI/NJ members, and those in career transition through a sharing environment specifically geared towards project management career paths;
 - • help members to envision the “real life” possibilities for their careers through interaction, sharing ideas, and discussions with guest recruiters, hiring managers, and other key players;
 - • create job leads and referrals for members that come to fruition through effective business relationship building;
 - • recruit new members and active business partners as CNP credibility grows;
 - • create a model for others to emulate, increasing the potential of a large Tri-State networking group that hiring managers think of FIRST in recruiting project managers
 - **Functions:**
 - • Each CNP meeting will feature group discussion and/or a recruiter, hiring manager, or other worthwhile guest, so that attendees will have a real flavor for hiring priorities for project managers by industry: IT, telecommunications, insurance, biotech and so on. The mutual exposure is followed up by both sides through email distribution of a roster.
 - • CNP's interactive format (full agenda attached) enables attendees to have equal dialogue time within a large group while refining their “elevator” introduction.
 - • Completed surveys from each monthly meeting will contribute towards the continued revitalization of the meeting according to membership input.



OVERVIEW OF PMI/NJ NETWORKING PROGRAM (cont.)

Future Phases:

- As PMI/NJ members' needs rise to an adequate level to make additional programs worthwhile, PMI/NJ will develop other networking functions, not limited to the following list:
 - Mentoring
 - Project Management Job Workgroups
 - Regional CNP meetings
 - Business networking and collaboration

(Effective March, 2003)

Category 1: Formal Academic Education

- One (1) hour of degree credit in a typical 15-week semester earns 15 PDUs.
- One (1) quarter semester hour earns 10 PDUs.
When only a portion of a course relates to project management, PDUs are calculated on a percentage of the overall curriculum focused on project management.
Documentation Required: A transcript or grade report indicating a passing mark.

Category 2: Professional Activities and Self-directed Learning

- A - Author or co-author of article pertaining to project management published in a refereed journal. (e.g. Project Management Journal ®)
30 PDUs per article (author); 20 PDUs per article (co-author)
- B - Author or co-author of article pertaining to project management published in a non-refereed journal. (e.g. PM Network ®)
15 PDUs per article (author); 10 PDUs per article (co-author)
- C - Speaker on project management topic at a conference, symposium, workshop or formal course.
10 PDUs per activity
- D - Speaker on a project management topic at PMI Component meeting. (e.g. Chapter meeting)
5 PDUs per activity
- E - Member or moderator of a project management panel discussion at a conference, symposium, workshop or formal course.
5 PDUs per activity
- F - Author or co-author of textbook that pertains to project management.
40 PDUs (author); 20 PDUs (co-author)



Professional Development Units

PDU's (cont.)

Category 2: Professional Activities and Self-directed Learning (cont.)

- G - Developer of content for seminar or other structured learning program.
10 PDUs per new program
- H - Practitioner of project management services for more than 1,500 hours per year.
5 PDUs per calendar year (Maximum of 15 PDUs may be earned per CCR cycle)
- SDL - Self-directed learning activities are individualized learning projects involving personally conducted research or study. Qualifying self-directed learning activities must be relevant to project management, meet a specified purpose, and use knowledgeable resources.
1 PDU for each hour (Maximum of 15 PDUs may be earned per CCR cycle.)
- Documentation Required: Copies of publications, sample educational materials or program agendas, or for SDL, evidence supporting the reported learning project.

Category 3: PMI Registered Education Providers

- Attending educational programs offered by PMI Registered Education Providers.
Certificates will be issued indicating the number of PDUs.

Category 4: Other Provider

- Attending relevant educational programs offered by organizations not registered with PMI.
1 PDU per 1 contact hour of learning relevant to project management.

PDU's (cont.)

Category 5: Volunteer Service to Professional or Community Organizations

- A maximum of 20 PDUs may be earned per cycle through professional service or by providing noncompensated project management services to nonemployer or nonclient customer groups. **No PDUs are awarded for service less than three months.**
- Officer for a project management organization.
 - 2 PDUs for 3 months
 - 5 PDUs for 6 months
 - 10 PDUs for 12 months
- Committee member for a project management organization.
 - 1 PDU for 3 months
 - 3 PDUs for 6 months
 - 5 PDUs for 12 months
- Provide project management related services to a community or charitable group
 - 5 PDUs per year

How do you earn your credential?

To be eligible for a PMP® or CAPM® Credential, you must first meet specific educational and/or project management experience requirements and agree to adhere to a code of professional conduct. The final step in gaining your credential is a rigorous multiple-choice examination designed to objectively assess your project management knowledge. The PMP examination utilizes scenario or application-based questions where practitioners are asked to apply their knowledge to specific situations. The CAPM examination utilizes definition type of questions assessing candidates' knowledge of project management terms and context in which project management is practiced.

Everything you need to know about PMI's exams:

PMI® develops its examinations based on examination specifications. These documents are derived from globally validated research processes. This research processes clearly set the credentials apart from other project management certifications. By identifying the globally-validated tasks, knowledge and skills involved in leading and directing project tasks (PMP) and project management terms and contexts (CAPM), PMI ensures that our examinations are content-valid. And that's important because it assures you that you passed an examination that demonstrates that you have the knowledge from which you can competently practice as a project manager (PMP) or that you have demonstrated knowledge about project management terms and contexts as contained in the *PMBOK® Guide – Third Edition* (CAPM).
